1. Typology of personal data processed

The following personal data may be processed: personal data, tax data, contact details, bank details and other administrative or commercial data necessary for the purposes below.

2. Objectives of treatment

The data will be processed for the following objectives: fulfilment of legal obligations and execution of the contract of which you are part, fulfilment of obligations towards the financial administration of the Government, accounting and administrative management, management of business relationships and litigation management.

3. Legal basis

The treatment of legal basis is made up of the execution of the contract and of the necessity to fulfill the obligations established by current regulations.

4. Provision

Providing requested information is mandatory to fulfil legal and contractual obligations, therefore any refusal to provide them will determine the impossibility for the writer to execute the contract or to perform correctly all the tasks required by the purposes indicated in point 2.

5. Storage time

The data will be stored for all the required time to pursuit above purposes and in any case not beyond the terms provided by specific legal obligations.

6. Recipients of personal data

Personal data will be treated by the staff in charge, properly instructed and working under the authority and responsibility of the holder. Some of the information may be communicated to the following subjects:

- Public Authorities
- Legal or consultancy offices to which the owner has given specific mandate;
- Computer systems servicing and maintenance companies or computer storage system providers
- Others subjects or companies who carry out ancillary activities to above purposes.

To the above subjects will be communicated only data strictly necessary to the accomplishment of the relative functions. 7. Rights of data subjects

We also inform you that, with regard to the data, you can exercise at any time the rights provided in Chapter III of the Regulation. In particular, you have the right to ask to the Data Controller for the access to the data concerning you, their rectification or cancellation, the integration of incomplete data, the restriction of processing; to receive the data in a structured format, of common use and readable by automatic device; to oppose in whole or in part to the use of the data, as well as to exercise the other rights granted to you by the applicable discipline.
